THE INDUSTRIAL RELATIONS REGULATIONS, 1982

LEGAL NOTICE NO.53 OF 1982

AUTHORISATION FOR THE DEDUCTION FROM WAGES OF FEES PAYABLE TO ORGANISATION

SWAZILAND NATIONAL ASSOCIATION OF TEACHERS

I hereby certify

- that I am employed by the SWAZILAND GOVERNMENT MINISTRY OF EDUCATION
- that I am eligible to be a member of the SWAZILAND NATIONAL ASSOCIATION OF TEACHERS.
- that the Association is authorized to request to deduct from wages due to me the amount of **0.7%** every month and thereafter remit the amount so deducted to the Association in Payment of Subscription due to the Association by me.

This authorization takes effect as from

This authorization may be revoked by me by written notice to the Association whereupon the Association shall: -

- notify the employer or such revocation **within seven days** of the receipt thereof:
- request the employer to cease making the deduction authorized by paragraph 1 (c) with effect from the pay period next following the amount in which the written notice of revocation was submitted to the Association by me.
